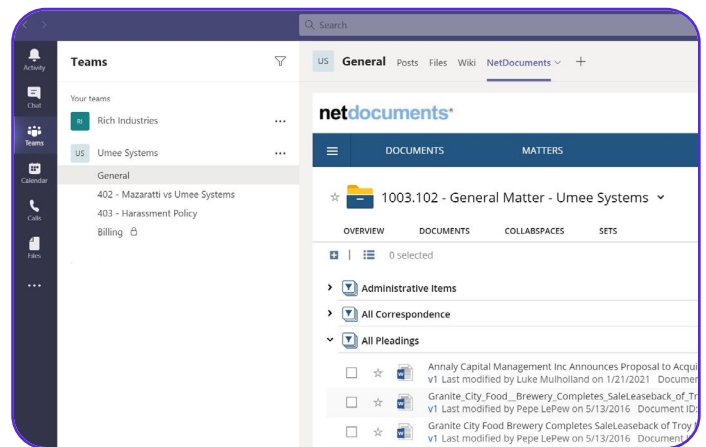

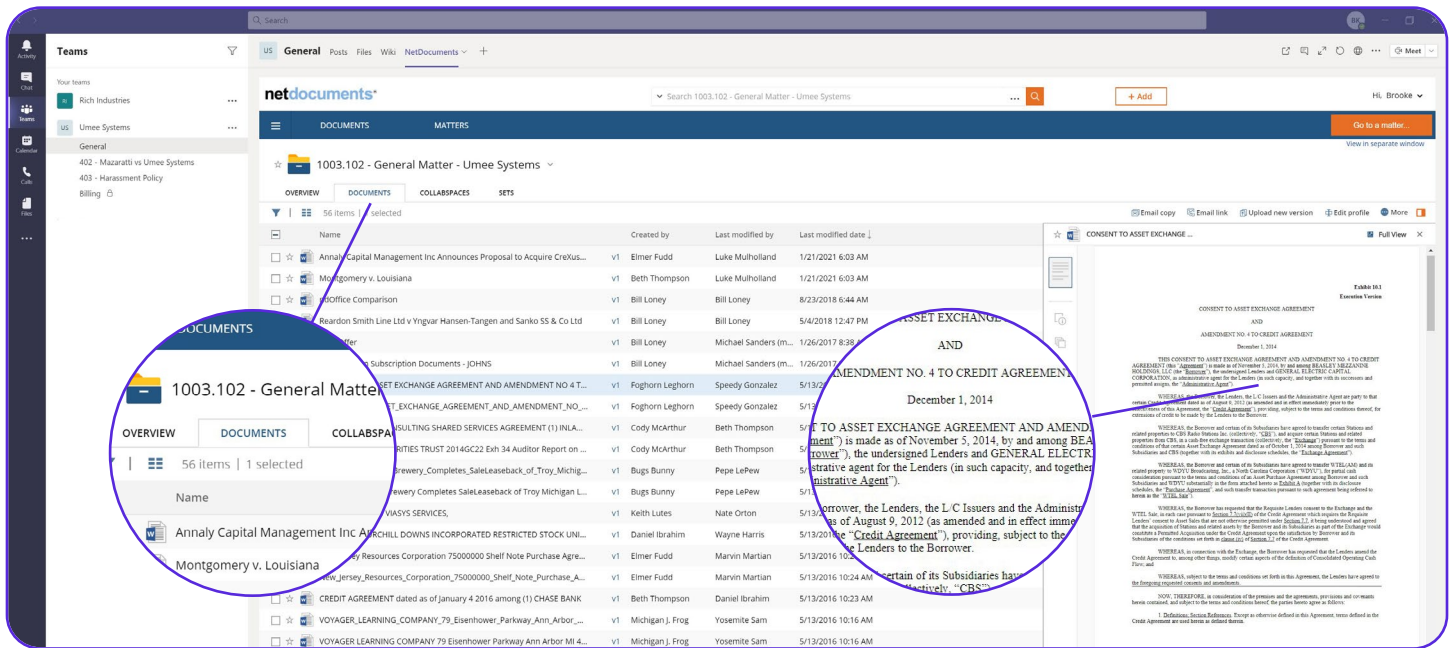

- **Documents uploaded in the Posts tab** will make it possible for files uploaded to a Teams channel to be automatically previewed, linked, and accessible to NetDocuments users.
- **In-line document previewing**, or 'unfurling,' will provide a quick preview of a file stored in NetDocuments within the Teams interface.

## ndMail

The ndMail integration provides a suite of email management and productivity tools for legal and corporate professionals who operate within Outlook.

Leveraging predictive filing, machine learning, and artificial intelligence, lawyers and legal professionals can file email into NetDocuments accurately, quickly, and with minimal effort.

Additionally, ndMail provides a window into a user's NetDocuments repository, boosting productivity by searching, managing, and viewing NetDocuments content without ever leaving Outlook.

## ndOffice

ndOffice provides deep integration into Microsoft Office applications and Adobe Acrobat. These integrations streamline workflows with documents, versions, and uploading documents directly to court websites or United States Patent and Trademark Office (USPTO) without having to download a local copy of the file.

The robust email attachment functionality inherent in ndOffice allows you to craft your email attachments in just the way you want the recipient to view them. This includes tailoring attachment names, their order, and even converting to PDF or zipping up the attachments on-the-fly.

ndOffice also allows you to quickly access your recent documents and document statuses via the Activity Center, always at your fingertips in your computer's system tray or the taskbar.

## FlexStore

FlexStore gives you control over the physical location of your data by facilitating geo-aware content storage through a single, convenient user interface. FlexStore can connect to any Microsoft Azure BLOB (binary large object) storage instance, in any of their highly secure service locations across the world.

## Power Automate Connector

The NetDocuments Connector for Microsoft Power Automate enables you to automate time-consuming manual processes by adding cross platform workflows and robotic process automation to your NetDocuments solution.

Providing easy access to over 50 NetDocuments API calls, you will have the power to automate manual processes on documents, workspaces, folders, users, and groups in NetDocuments through Microsoft Power Automate.

With this tool, you can automatically create WorkSpaces and CollabSpaces, add users to a repository, create groups, add users or groups to a cabinet, and more, giving you time to focus on other strategic initiatives.

## NetDocuments to Office 365 Data Loss Prevention (DLP) Integration

NetDocuments DLP allows you to create and apply classifications and policies that control the actions authorized users can take, in order to prevent documents from being removed from the NetDocuments repository maliciously or accidentally.

In coordination with Microsoft, NetDocuments is developing a robust integration between the Data Loss Prevention (DLP) capabilities found in NetDocuments and those provided by Office 365 DLP.

DLP policies found in the Office 365 Security & Compliance Center today allow you to identify, monitor, and protect sensitive information.

As the NetDocuments integration is finalized later this year, your Office 365 and NetDocuments DLP policies will be connected and able to operate in sync.

## Microsoft Cloud Application Security (MCAS)

Planned for mid-to-late 2021, NetDocuments will provide a connector to Microsoft Cloud Application Security—a multi-mode Cloud Application Security Broker (CASB). This connection will provide visibility into your cloud applications and services, leveraging sophisticated analytics, to help you identify and combat a variety of cyberthreats.
